Understanding the dangers of **5G** and **Chemtrails**

Preface

History and our experiences tell us every day that our decisions have an important influence on our surroundings. The same is true of our decisions on the evolution of technology.

Since the first industrial revolution, a little over 200 years ago, we have been confronted with an industrial development guided by capitalism: first make profit and then we will see whatever they may try to make us believe. It's not the inventors or the discoverers of the technologies that are responsible for the evolution we know, but those who want to exploit these technologies for their own benefit and who, through lobby and Astroturf techniques, try at all costs to introduce the technologies that interest them as necessary and inevitable to the economic evolution and to be so-called profitable for everyone.

We are all co-responsible for the evolution we know, but some people are much more than others. Greater responsibility is found among politicians who are informed by experts and authorities in this area. However, we must know that large corporations and multinationals are primarily focusing their profit and they will not hesitate to juggle data and impose their laws.

As an engineer and molecular biologist I try to play my role in informing you of the dangers and their consequences. I'm aware of the economic stakes, it's about tens, even hundreds of billions of Euro of economic benefit, but that does not compare with the well-being and health of humans and nature at the whole.


I do not want to point or judge anyone. On the other hand, I want to sound the alarm before the situation deteriorates in disaster. We are allowed to make mistakes, but we must correct them immediately to avoid dramas. Many people are already living in pain and I thank you in advance for taking into account the information I am going to give you.

Understanding the functioning of the body

I first want to introduce you to the functioning of the body in a simplified way so that you can more easily understand the impact that waves can have on the body. I rely on the information at my disposal.

The universe consists of a set of plasma magnetic fields. These fields have an influence on each other. By weakening, these magnetic fields can become matter according to certain conditions, according to the gravitational and magnetic fields which prevail. These fields attract or repel each other and are in a permanent state of 'motion'. Dynamic magnetic fields of the same magnitude bend so that they form a field of circular force. These circular fields can be seen observing magnets, earth, sun, planets, stars, galaxies and atoms.

Dynamic magnetic fields can change to other forms of existence: antimatter, dark matter and matter. Finally, this explains why in chemistry, we speak about attraction or repulsion between the atoms (a set of protons and electrons): Anions and Cations.




From these magnetic fields, a wide range of material can be created, such as: hydrogen, nitrogen, oxygen, carbon. These four elements mentioned form the basis of amino acids, the life we know on earth. Of these four elements, carbon is the only element, here on earth, that comes in solid form. The other three elements are gases. All of this has to do with the magnetic situation we have on the earth and the conditions present in the atmosphere. But nothing prevents that in the universe the same conditions can be created.

Intelligence lies in the storage of information. Carbon as such we know is a very good conductor (graphite). When the magnetic dynamic fields, which create the carbon, are subjected to a different configuration, it is possible that they generate carbon with other physical characteristics, for example the carbon can become a very good insulator (the diamond). Some will say that it is because of high pressure that the diamond is created. But the pressure is due to what? Gravitation and magnetic fields that are omnipresent.

Our brain is mainly composed of carbon. It is interesting to note that the carbon then acts as a conductor or as an insulator depending on the influence of the magnetic fields that act on it. on the same principle. The nerves themselves function as conductors, the myelin around acts as an insulator, so that no short circuit or loss of power can occur. If there is a 'short circuit', the information from our brain is sent to other places than originally planned and the stomach is usually the central receiver of any misplaced information.



Dr. Bernard Blanc of the Institute of Biochemistry at the University of Lausanne and Dr. Hans Hertel, who is connected to the Research Institute of Environmental Biology at Wattenwil, made a review in 1989 of the effect of a magnetron on different foods and the consequences of this diet for the quality of human blood.

Today this ionosphere is flooded by microwaves antennas, mobile phones and satellites, namely 10¹¹ to 10¹⁸ more than before 1940. 10¹¹ means 100 billion times more and 10¹⁸ means you multiply the previous number by 10 million, to give you an idea of the amplification of the intensity to which we are subjected daily.

The different barriers of natural protection of the brain, testicles, eyes, etc. can no longer protect the organ sufficiently by blocking the direct contact with the blood and leaks of blood to these bodies appear and whose importance is related to the intensity of microwaves. This means that the functioning of the organs in question deteriorates in proportion to the intensity of the microwaves to which the organs are subjected. Finally, this results in different tumors.


The image below explains the sensitivity of different parts of the brain: Take the example of the traditional mobile phone that emits at 1W / kg. The brain's cortex is sensitive from 0.1W/kg and the more we point to the center of the brain, the more that the area becomes sensitive and that it does not need more than 0.001W/kg (one milli Watt/kg) to achieve serious long-term consequences.



In order not to exceed 1milliW/kg, the mobile phone should be kept at a distance of 1.85m from the ear as shown in the diagram below. Most people literally stick the mobile phone to the ear and in the medium term the first indications of cancer will manifest. Some people are more sensitive to microwaves than others




And when it comes to antennas for communicating with mobile phones, Dr. Salford's chart states that a $\underline{minimum}$ distance of 190m must be kept to not exceed 1mW / kg



As already announced, there are people who are more sensitive than others. In 2010, it is announced that more than 3% of the population already suffers from hypersensitivity to the radio waves. For less sensitive people, difficult to understand. These numbers refer to 3G.

With the advent of 5G, the situation will get worse. In order to function properly, the 5G antennas must be located much lower and at shorter distances from each other. An antenna every 100m. Each living being will be flooded by radio waves at much shorter distances: from 50m as the absolute maximum up to 10m.





The accepted official standard limit is 6V/m at 25m. We now go to 14.5V/m at 25m as acceptable intensity to meet the demand of the operators.




But there is more..

The multinationals are deceiving us by hiding the real functioning of 5G.


Unlike previous systems, the 5G system uses 64 beam emitters at the same time (8 out of 8) to dramatically increase information throughput: 100 times more data at 100 times faster speed.



According to the information of the manufacturer Ericsson 61V/m are necessary to work well at 25m where before 6V/m was admitted. This is 10 times more. A maximum of only 7 minutes is allowed at 61V/m. But at a distance of 11m (antennas lower and closer) we reach 120V/m. However, with the antennas 5G it is not excluded that people can stay even closer to the antenna than 11m.



To respond to this change, the ICNIRP, a private organization, has adapted the standards and from now on in offices it is accepted to go up to 200V/m and in homes up to 90V/m. Thus operators officially meet the standards for justice. The WHO will accept these indications as the standards to follow !!

5G is the term used to describe the next-generation of mobile networks beyond the 4G LTE mobile networks commonly used today. 5G is intended to be the technology that allows the Internet of Things (IOT) to exist and tie all internet connected devices together.

Currently there is no standard for 5G networks in place and it will be a combination of a variety of frequencies and modulations. Industry is developing exactly what 5G will be as the standard has not been set yet. It is assumed that 5G networks will not become commercially available until 2020 but several cities are rolling out 5G as test areas *now*. Verizon and Sprint have announced "test cities" for 5G which include Sacramento, Washington DC, Atlanta, Dallas, Miami and New York.

A first glance at US government websites such as the CDC and EPA could lead you to believe that this radiation is safe. Yet over 240 scientists and doctors from 41 nations who have published research in the field have appealed to the United Nations calling for urgent action to reduce these ever growing wireless exposures and they wrote the FCC for a moratorium on the roll-out of 5G citing the serious risks that to human health and the environment.

The Constitution Is Clear: Please find the follow-up to my communication on the transmission of illegal radio frequency signals from the cellular and micro towers in Tampa/St Petersburg, and its surrounding areas. My observations are based on clear scientific and engineering principles and data.

I am a Ph.D. from Princeton University and a former scientist from Los Alamos National Laboratory in New Mexico where I worked within nuclear weapon research teams. I held a Q clearance (top secret equivalent of DoD). I have also worked on DARPA research projects as a senior scientist.

There is a technology transmitting RF signals and communications at the human brain resonant frequency bands, and it is targeting individuals and groups.

These transmissions will cause harmful health affects in the form of enhanced microwave radiation illness. It is imperative that these frequency bands be measured and verified by an official source. These frequency bands do not exist naturally, and there is a technology targeting individuals.

Cellular transmission's broadcast at 853 MHz, human brain resonance is centered around 450Mhz, and Ham radio operators are not allowed to broadcast at the 400Mhz to 700Mhz band. I would suggest a filtering at the 400Mhz to 700Mhz band on all microwave and cellular transmissions, digital filters should suffice in the near term. Let's first decipher the terms CONTRAILS and CHEMTRAILS

Contrail means condense trail, a trace of condensation.. Where does this condensation come from ? From the burning of kerosene, the fuel for planes. Kerosene is a hydrocarbon, a derivative of oil. As its name suggests, the hydrocarbon is a chain of carbon atoms and hydrogen atoms.


Kerosene has 10 to 16 carbon atoms and 22 to 34 hydrogen atoms that burn to generate heat and energy to move airplanes.



Typical to the combustion of hydrocarbons is the production of CO2 and H2O.

Combustion or explosion is a rapid oxidation process. With its more powerful attraction force, oxygen manages to separate hydrogen from carbon and to separate the carbon atoms between them, to form on the one hand CO2 molecules whose number of molecules is equal to the number of carbon atoms present in the hydrocarbon molecule and on the other hand in H2O in the form of water vapor.

CO2 is a greenhouse gas. The same is true for water vapor, which is not known to the general public. Just like CO2, moisture in the air keeps the air warmer, but with the only difference that water vapor is almost 20 times more present in the air than CO2. As a result, CO2 is not mentioned in the air psychrometric chart because CO2 has very little influence compared to water vapor in terms of caloric content. The diagram below shows that for the same temperature of 22°C, the air includes more heat at 55% relative humidity than 40% relative humidity.



For the same temperature (here 22°C) a wetter air contains more water vapor when the relative humidity rises. On the diagram we see 9g/kg dry air for 22°C, 55% RH against 6.6g/kg dry air for 22°C, 40% RH (RH = relative humidity). The expression in g/kg dry air represents the absolute humidity contained in the air.

It is known that warmer air is lighter than colder air with the same absolute vapor content. What is less known is that for the same temperature the wetter air is lighter than the dry air, which is why tons of water can fly over us in the form of clouds.

But how is it that air that contains more water vapor can weigh less than dry air ?



To the right of the 9 g/kg indicated on the diagram, it is also indicated the number 15 which announces the vapor pressure under this condition. The same is true for the 6.6 g/kg where we can read 11. This means that the water vapor creates a tension (a pressure) which is expressed in mbar (millibar) or hPa (hecto Pascal) as on the barometer.

Where does this tension come from? The vapor molecules separate the molecules from the air to settle there and given the vapor (H2O) weighs much less than the air, this volume therefore weighs less than the dry air.

So it's not just the air temperature that plays a role in the weight of the air.

By the pressure difference, the air start to move to find a balance.

When one carefully observes the edges of the clouds for several minutes which circulate in a sky not too cloudy, one can note that the edges of clouds disappear from sight progressively. This means that the contour of the clouds which is in contact with the surrounding air dissolves very slowly by the fact that a balance is put in place between the air almost saturated with water vapor and the unsaturated air.

Due to the pressure difference between moist air (cloud) and dry air, water vapor moves to drier air. It can be seen that a slight cloud disappears from view after a few minutes.

It is the same with the traces of condensation of the planes. An airplane with jet engines traveling in the air at a speed of nearly 800 km/h cannot leave behind a dense cloud that lags for hours, but rather a condensation that scatters quickly and then disappears from the view.

Depending on the atmospheric conditions, the condensation trace of an airplane does not last more than 7 to 30 seconds and then the trace of condensation disappeared because of the difference in pressure which circulates the water vapor in volumes of drier air.

By verifying the vicinity of the cooling towers of power plants that discharge significantly more water vapor than an aircraft reactor, it never happens that a permanent fog settles, even in very rainy atmospheric conditions.

Although the towers produce more water vapor and are immobile, the water vapor released into the air disappears after a certain time and this according to the same physical law: pressure difference = movement of the air ... and the water vapor is absorbed in the surrounding air volumes, even at very cold temperatures or in very cloudy weather.



Below, on the two photos at the top left, made in winter, we can barely see the aircraft drag. They were contrails and it was -8 °C. The other photos were made in summer.




Then the following question arises:

The French PAQUID study followed for over eight years more than 3,700 volunteers. The authors conclude that people whose drinking water contains more than 0.1mg of aluminum per liter are twice as likely to develop Alzheimer's disease. This study also shows that when the silica concentration is higher than 11.25mg/l the risk is lower than when the water is low in silica, since in this case the risk of Alzheimer's is reduced by 27%. Cadmium poisoning can be acute or chronic, with mainly pulmonary, bony and renal lesions. The average cadmium content ("Cd" notation) of equine offal (horse, donkey, mullet, donkey) is approximately 10 μ g / g of cadmium. The temporary tolerable daily intake ("TDTT") of cadmium having been statutorily limited to a maximum of 1 μ g • kg-1 • d-1, any marketing of offal of "late slaughtered" equidae is prohibited. Indeed, even if these offals were the only dietary source of cadmium for humans, this ban would be

justified because an average weekly consumption of only 100g of offal would lead to exposing the consumer to $1.000 \mu g$ / week, ie for someone from 60kg, more than double the TDTT, which limits it to a Cd intake of less than 60 μg per day, ie 420 μg / week

EFSA has set a **tolerable weekly intake (DHT) of 2.5µg/kg** body weight for cadmium (**150µg/week**), which is 3 times lower than announced in Wikipedia !!

Cadmium seems above all to be harmful to the kidneys. The effects are manifested with age. The International Agency for Research on Cancer (IARC) has classified cadmium as a carcinogen.

Cadmium has no physiological role in the human body. The metal itself and its compounds are extremely toxic, even at low concentrations, and <u>tend to accumulate in living</u> organisms and ecosystems.

Barium :

Barium reacts violently with water by giving barium hydroxide Ba (OH) 2, or hydrated baryta, which is **very toxic**.

Small amounts of these compounds may cause breathing difficulties, increased blood pressure, changes in heart rate, stomach irritation, muscle weakness, changes in nerve reflexes, inflammation of the brain and liver, kidney and heart damage. 

It must be understood that what is suspended in the air, collects in the rainwater and spreads in rivers and other streams and also seeps into the ground. If the aforementioned elements are harmful to the human body, so are the fauna and flora.

Across Europe and therefore also in Belgium rainwater analyzes have been done by independent laboratories at the request of valiant citizens with similar results: an abnormally high presence in Aluminum, Barium, Cadmium, etc

In Switzerland, someone has done an analysis of the rainwater collected in the jacuzzi on his terrace and the results are very surprising. Normally we would expect the mountain air in Switzerland to be healthy, but because of chemtrails the opposite is true :





In 1997 the chem-trails began raining down mysterious blobs of a gelatinous substance that look much like ice but was not cold. Some fell on my small farm. Crystalline Blobs from Space

Not long after the gelatin blobs, especially in May, spider-web material began falling from the sky during chem-trailing. At that time chem-trails were persistent "cloud" trails that were left after a jet passed overhead. Chem-trails were in their infancy and when looking up you would see one plane, two trails. The unusual patterns: checkerboard, crosses, X's, V's, and persistent gray haze did not begin until after the turn of the century.



H.R.2977 -- Space Preservation Act of 2001 (Introduced in House - IH)

107th CONGRESS 1st Session H. R. 2977

To preserve the cooperative, peaceful uses of space for the benefit of all humankind by permanently prohibiting the basing of weapons in space by the United States, and to require the President to take action to adopt and implement a world treaty beaning space-based weapons.

IN THE HOUSE OF REPRESENTATIVES

October 2, 2001

Mr. KUCINICH introduced the following bill, which was referred to the Committee on Science, and in addition to the Committees on Armed Services, and International Relations, for a period to be subsequently determined by Speaker, in each case for consideration of such provisions as fall which the jurisdition of the committee concerned

A BILL

To preserve the cooperative, peaceful uses of space for the benefit of all humankind by permanently prohibiting the basing of weapons in space by the United States, and to require the President to take action to adopt and implement a world treaty banning space-based weapons.

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled,

SECTION 1. SHORT TITLE.

This Act may be cited as the 'Space Preservation Act of 2001'.

SEC. 2. REAFFIRMATION OF POLICY ON THE PRESERVATION OF PEACE IN SPACE.

Congress reaffirms the policy expressed in section 102(a) of the National Aeronautics and Space Act of 1958 (42 U.S.C. 2451(a)), stating that It is the rest of the policy of the United States that activities in space should be devoted to peaceful purposes for the benefit of all maniformation.

SEC. 3. PERMANENT BAN ON BASING OF WEAPONS IN SPACE.

The President shall---

 (1) implement a permanent ban on space-based weapons of the United States and remove from space any existing space-based weapons of the United States; and
 (2) immediately order the permanent termination of research and development, testing, manufacturing, oroduction. and deployment of all space-based weapons of the United States and their components.

SEC. 4. WORLD AGREEMENT BANNING SPACE-BASED WEAPONS.

The President shall direct the United States representatives to the United Nations and other international organizations to immediately work toward negotisting, adopting, and implementing a world agreement banning space-based weapons. SEC. 5. REPORT.

The President shall submit to Congress not later than 90 days after the date of the enactment of this Act, and every 90 days thereafter, a report on-(1) the implementation of the permanent ban on space-based weapons required by section 3; and (2) progress toward negotisting, adopting, and implementing the agreement described in section 4.

SEC. 6. NON SPACE-BASED WEAPONS ACTIVITIES.

Nothing in this Act may be construed as prohibiting the use of funds for--

space exploration;
 space research and development;
 testing, manufacturing, or production that is not related to space-based weapons or systems; or
 vesting, manufacturing, or production that is not related to space-based weapons or systems; or
 vesting, and the space-based weapons or motivations; and gate and the space-based weapons or





(Table 14.1). Enron had on-balance sheet debts of \$31.2 billion and offbalance sheet debts and contingent liabilities of \$27 billion. In April 2002, Enron reported that a material portion of the assets at the time of bankruptcy was overstated by \$14 billion due to accounting errors and irregularities.³⁹

THE IMMEDIATE SPILLOVER EFFECTS

The immediate spillover effects of Enron's bankruptcy were relatively small and no major economic catastrophes are associated with it. Enron had over 21,000 employees worldwide. About 11,000 employees had their 401(k) retirement accounts invested in Enron stock that became worthless when it plunged from \$90 per share to a few cents per share. Kenneth Lay and other Enron executives also sustained large losses on the stock. However, Lay had benefits that were unavailable to other employees, such as prepaid life insurance premiums on a \$12 million life insurance policy.⁴⁰ Similarly, Jeffery Skilling had an \$8 million life insurance policy.

About 4,000 out of 7,500 Enron employees in Houston lost their jobs in connection with the bankruptcy. An additional 1,100 employees in London were laid off.

Other stock market investors lost billions of dollars. <u>Stock market analysts</u> from Goldman Sachs, Lehman Brothers, Solomon Smith Barney, and UBS Warburg recommended Enron's stock to investors even after some of its problems became public.⁴¹ Every mutual fund and pension plan that had a passive portfolio mimicking the S&P 500 lost money on Enron. Alliance Capital Management Holding LLP lost \$282 million for Florida's state pension fund by investing in Enron stock weeks before the company collapsed.⁴² Investment bank J P Morgan Chase may have lost about \$1.1 billion by investing in Enron partnerships. Some of that loss may be covered by insurance.⁴¹ CSFB had a loss of about \$126 million related to Enron.⁴⁴ Bank of America wrote off \$210 million in loans to Enron.⁴⁵ Northern Trust had \$43.5 million in unsecured loans to Enron, and \$24.5 million in secured loans.⁴⁶ Four of Australia's biggest banks, France's Credit Lyonnais, and Holland's ABN Amro all lost large sums.⁴⁷



Goldman Sachs To Pay Enron \$7M Over Securities

Law360, New York (January 8, 2009, 12:00 AM ET) -- Goldman Sachs & Co. has agreed to shell out nearly \$7 million to the Enron Creditors Recovery Corp. over commercial paper transactions leading up to the energy company's collapse in 2001. In a motion filed Thursday in the U.S. Bankruptcy Court for the Southern District of New York, Enron asked the court to approve the \$6.95 million deal with Goldman Sachs.

Enron's motion says that between Oct. 26, 2001, and Nov. 6, 2001, Enron paid more than \$1 billion on commercial paper prior to those securities reaching maturity. Enron filed for bankruptcy protection on Dec. 2, 2001.

Commercial paper, which includes promissory notes, is a money-market security considered a cheap alternative to bank loans. It is one of the biggest debt markets in the U.S. but requires no registration with the U.S. Securities and Exchange Commission.

In November 2003, Enron launched two adversary suits against about 180 parties over the payments, looking to recover hundreds of millions of dollars. A motion Goldman Sachs had filed seeking summary judgment in the proceedings is currently pending.

The settlement motion said the agreement will clearly benefit Enron, its estate and its creditors because it will result in a payment to the estate. It will also avoid future disputes and litigation regarding the investment bank's alleged involvement with the commercial paper transactions, according to the motion.

The deal is the latest in a string of such settlements. In July 2007, a number of companies — including Lehman Commercial Paper Inc., Aetna Inc., Allstate Life Insurance Co., Merrill Lynch Investment Managers LP, Prudential Life Insurance Co. of America and UBS Global Asset Management (Americas) Inc. — settled similar claims with Enron for more than \$149 million.



2. Astroturf

This practice is used in the media, social networks, Wikipedia, etc. by multinationals and other large corporations, governments, organizations or other authorities, through specialized offices to deliberately deceive the public that the policies of these institutions are voluntarily followed by the public.

The modus operandi is to launch misleading information inviting the public to react. Positive reactions are retained, negative information is immediately discarded. So, readers only see positive reactions. Whistleblowers of these practices, who may be journalists, politicians, citizens, ... are discredited immediately by ridiculing them publicly and someone who has doubts about anything is quickly confronted with information from so-called experts in the matter.

Astroturf is a highly effective lobby technique and is used continuously today. Proof is the recent development of an organized ecological movement in which young students who have been totally brainwashed are given a leading role to push politicians towards more drastic measures that will naturally cost the population a huge amount of money through Eco-taxes and other procedures and that will drive our civilization to a complete chaos.

The term Astroturf is derived from AstroTurf, a synthetic carpet brand designed to look like natural grass, like a word game "information at the source".

'Organizations can hire fake advocates who create the illusion of real support for their message. It's a shady practice called astroturfing that can warp the public perception of anything... even astroturfing.'

3. The strategy of DIVERSION

The strategy of diversion is to divert the public's attention from the important problems and mutations decided by the political and economic elites, thanks to a continual flood of distractions and insignificant information.

4. SHOCK and SOLUTION strategy

First, a problem is created, a "situation" that is designed to elicit a certain reaction from the public, so that the public is itself asking for the measures one want them to accept.

- Ex : allow urban violence to flourish so that the public ask for security laws to the detriment of freedom.
 - create an economic crisis to make accept as a necessary evil the decline of social rights and the dismantling of public services.

5. The strategy of Degradation

To make accept an unacceptable measure, it is enough to apply it gradually, in gradient over a period of 10 years. This is how the radically new socio-economic conditions (neoliberalism) were imposed during the 1980s and 1990s. Massive unemployment, precariousness, flexibility, relocations, wages no longer ensuring a decent income, as many changes that would have caused a revolution if they had been brutally applied.

6. The strategy of postponing

Another way to get an unpopular decision accepted is to present it as 'painful but necessary', getting the public's agreement in the present for an application in the future. It is always easier to accept a future sacrifice than an immediate sacrifice because the effort is not forthcoming and the public always tends to naively hope that "everything will be better tomorrow".

Finally, it gives the public time to get used to the idea of change and accept it with resignation when the time comes.

7. The strategy of infantilization

Most consumer-oriented commercials use particularly infantilizing speech, arguments, characters and tone, often close to the debilitating, as if the viewer was an infant or mentally disabled person. The more we try to deceive the viewer, the more we adopt a childish tone. Why ? If one speaks to a person as if she were 12 years old, then, because of the suggestibility, she will, with a certain probability, have an uncritical response or reaction as of a person of 12 years.

8. The strategy of emotion

Appealing to the emotional is a classic technique to bypass the rational analysis, and therefore the critical sense of individuals.

In addition, the use of the emotional register opens the door to access the unconscious to implant ideas, desires, fears, impulses, or behaviors...

9. The strategy of ignorance

To ensure that the public is unable to understand the technologies and methods used for its control and slavery. The quality of education given to the lower classes must be poor, so that the gap of ignorance that isolates the lower classes from the upper classes remains incomprehensible to the lower classes.

Ex. Through animations for children, the children are conditioned that the chemtrails are normal. Thus, these children when they become adults will not ask questions.



10. The strategt of mediocrity

Encourage the public to indulge in mediocrity, by encouraging it to find 'cool' being stupid, vulgar and uneducated by elevating them to idols and role models, the most stupid people possible, through of the most alienating and debilitating entertainment programs.

11. The strategy of guilt

Make the individual believe that he alone is responsible for his misfortune, because of the insufficiency of his intelligence, of his abilities, or of his efforts.


Thus, instead of revolting against the economic system, the individual depreciates himself and feels guilty, which generates a depressive state, one of whose effects is the inhibition of any action. And without action there is no contest.

12. The strategy of knowledge

Over the last 50 years, the rapid progress of science has widened the gap between public knowledge and the one held and used by the ruling elites. Thanks to biology, neurobiology and applied psychology, the "system" has come to an advanced knowledge of the human being, both physically and psychologically. The system has succeed to know the average individual better than the individual knows himself. This means that in the majority of cases the system has greater control and power over individuals than the individuals themselves.


In this work the writer investigates on the operation of the 'Tavistock Institute for Human Behaviour', an institute that finds its origin in the theories of Sigmund Freud. The pioneering work of Tavistock was to use the Freudian theories to provide a base to control and dominate the human brain. From the University of Sussex, the network expanded towards the United States to the Stanford Research Institute, the Esalen Institute, the MIT, the Hudson Institute, the Heritage Foundation, the Centre for Strategic and International Studies at Georgetown where some deputies from the U.S. were trained, plus the US Air Force Intelligence and the RAND Corporation en the MITRE Corporation. In his book Dr. Coleman describes that the staff was obliged to undergo indoctrination in one or more Tavistock controlled institutes. Besides the above-described network, there exists an additional network of secret groups as the Mont Pelerin Society, the Trilateral Commission, the American Ditchley Foundation and the Club of Rome that functions as a transit channel for the instructions to the Tavistock network. Wind turbines produce energy with the wind. So, they are ecological. Really?


For stability, a wind turbine is anchored in a concrete support. 50 to 100 tons of concrete are poured into the soil for one wind turbine. Not very ecological ... but it's not just that...

Do you know how cement is made to create concrete?

In my career I had a period where I did technical audits of companies. One of them was a cement factory. I started to visit a quarry where huge cranes and bulldozers are busy collecting pieces of rock and then depositing them on trucks with a capacity of 75 ton, all of them emit a lot of CO2.



What is harvested from the quarries is transported to the factory to be poured into crushers that require a lot of electrical energy to break the rocks into smaller pieces.



Using conveyor belts, debris are stored in sheds for pre-homogenization. All this is motorized and powered by electricity.

Then, what is prehomogenized is transported to the grinders that are powered by high power electric motors.


From there, the material is transported to a homogenization system and then transported to a granulation system before ending up in a huge rotary kiln (almost 200m long) and operating between 850 ° C up to 1600 ° C. All this transport and the rotary kiln are powered by electricity and given the scale, consumption is not low. And kiln nearly 200m long then. а operating high temperatures at consumes of course a lot of gas also producing a lot of CO2


From the kiln, the material is then transported to a cooler and from there to the storage of clinkers. The clinkers are then crushed again to make a powdery mixture to which substances are added to obtain the finished product which will be stored in silos. A distribution system then distributes cement to trucks or train cars for transportation to wholesalers where the cement will be packed or prepared for shipyards ..

As you have noticed, before the cement is used, it followed an energetically very intense route with a lot of CO2 production.

And we have not talked about the production of wind turbines per se

Wind turbines are made of steel sheets and structures. The images below already give you a good impression of the energy it costs to produce them.





And then you still have to transport everything on site and do the assembly with the help of a crane. All this requires a lot of polluting energy that produces CO2. And pouring 50 to 100 tonnes of concrete into the soil is not really positive for microorganisms that are introduced in a much more aggressive environment. Cement/concrete is not a neutral product.

The efficiency of the wind turbines is not praisable, because we do not control the wind that makes the blades move.

And don't forget the damage that wind turbines can cause... thousands of birds are killed because of the blades.

These wind turbines cost a fortune to manufacture and install them and they do not permanently produce electricity. I abstain from judging on the aesthetics and the inconvenience by the noise for its entourage.

Electric cars. The miraculous solution, hallelujah!

It is true that the electric motor has a better performance and it does not pollute directly, but we have to come back on earth. Be aware that an electric car runs on batteries that need to be recharged.

Our strength also lies in the refusal to use the 5G and abstain from using aircrafts. Since they think in terms of profit, they will quickly understand the meaning of the word deficit.


You find that there is too much pollution?
